# Hvad er tanken bag en Suite?


## Suite - definition:

- [www.yourdictionary.com](http://www.yourdictionary.com):
  - “A group of related things intended to be used together; a set.”
  - Computer science:  
“A group of software products packaged and sold together, usually having a consistent look and feel, a common installation, and shared macros”
- Tanken er at skabe “Truly Integrated Applications”

Gartner, Sep. 2010 - Truly Integrated Applications:

“When healthcare application products are designed to work together, are built by a common team using a common application infrastructure, and are based on a common database schema, Gartner refers to them as truly integrated.”

## Suitens fordele: Truly integrated application

Datadeling frem for dataudveksling (semantik)

Umiddelbar anvendelse af data til statistikformål

- Eks. fra Cosmic: BI kan leveres som modul i Suiten.

- Uddannelse og kommunikation bliver enklere

# Hvorfor og hvornår skal man vælge en suite?

- Gartner, 2007/Sep. 2010, ID; G00206865
  - Anbefalinger:
    - Benyt ikke som udgangspunkt "best of breed" som den primære valgmulighed til kliniske systemer.
      - Treat application integration as a compromise approach used to temporarily extend the useful life of an old system or meet an ad hoc requirement after careful case-by-case analysis. Do not embrace "best of breed" as the first choice for clinical systems or other highly complex enterprise applications.
    - Læg vægt på "truly integrated applications" hvor komplekse strukturerede kliniske detaljer skal være overensstemmende i enhver kontekst og forløb.
      - Favor truly integrated applications where very complex structured clinical detail must match in every detail or the workflow passes between the two applications very frequently.
    - Healthcare Organisationer som overvejer integration af modulære EHR komponenter, bør anvende kriterier som angivet i rapporten.
      - HDOs contemplating application integration of modular electronic health record (EHR) components must use the criteria in this research to decide whether a solution that meets certification requirements is tenable for their operation.
